1. Request for criminal record checks are restricted to residents of Moncton, Dieppe and Riverview.
2. The cost for a criminal records check is \$20.00. A cheque or money order payable to the City of Moncton will be accepted. Cash and debit can only be accepted at Moncton City Hall Revenue Office. Business hours of the Moncton city Hall Revenue Office are Monday to Friday, 8:30 a.m.- 4:30 p.m. If payment is made at City Hall, the receipt must be brought to the Codiac RCMP Detachment.
3. Requests at the Codiac RCMP Detachment are only accepted between the hours of 7:30 a.m. and 5:45 p.m.
4. The Applicant must provide, with their request, an addressed stamped envelope and two (2) pieces of identification.
